AREA OF OPERATON: STATE OF GOA

AIMS AND OBJECTS OF THE SOCIETY ARE:

- a. To advance, promote literacy and general education in such subjects as the Society may think fit among the public;
- b. To establish, take over and administer and conduct, schools, colleges, coaching classes in all or any subjects and to undertake all activities; relating to education;
- c. To establish, take over and administer Societies, Trusts, Institutes, Colleges and schools in specialized fields and to undertake all activities relating to education;
- d. To advice the Diocesan Authorities to control expansion, limitations and suppression of Educational Institutions with due regard to the interests of the Church, the State and the Institutions concerned;
- e. To advise the Diocesan Authorities in the promotion and expansion of Catholic Educational Institutions in areas where a need may be felt to promote such institutions;
- f. To cater in particular, to the education needs of the children of the Catholic Minority Community; and in general, to the needs of the children of other communities; considering that one of the obligations of the Catholic Church is to provide education to the children of the Catholic Community in keeping with the tenets of the Catholic Church and considering the universal character of the Catholic Church, the Society shall also cater to the needs of the children of other communities in general, irrespective of caste, creed or religion.

- g. To carry forward the above object and to cater to the needs of poor and deserving students in general; and in particular of the Catholic minority community;
- h. To co-operate with institutions and Associations having similar aims and objects;
- i. To acquire by purchase or otherwise hold on lease, hire or rent or by exchange, any moveable or immovable property or properties;
- j. To sell, give on lease or hire any property of the Society;
- k. To borrow moneys for carrying out of the objects of the Society and for that purpose, to create security by mortgage, charge or pledge or hypothecation of any immovable or moveable property of the society;
- l. To establish any fund to further the interest of the Society;
- m. To engage in any other lawful activity which may be conducive to the promotion of any or all the objects of the Society mentioned above on no profit motive;
- n. To undertake such other activities which are conducive for promotion of the above mentioned objects.
- o. To promote art, music, drama, fine arts, literature and culture in general.





